- WWP response to DENR Oct. 2 letter
  - WWP are hiring a consultant to put together response to DENR regarding (3) outstanding DENR issues
    - Public input, Environmental Justice, and Site Selection
  - Method WWP wants to use for public input is two fold. First, they intend on doing a door to door survey with people within a half mile radius and then one mile radius. NHCA Board will be working on how to inform and prepare residents for the interview. Once data is obtained from initial public input survey, WWP expects to do a public meeting with the community
- Paul Barth received letters from Dave Cooke (Wake County Manager) responding to his email requesting Commissioners to do several things to support New Hill. Basically, the response said that Commissioners were involved until project turned over to Cary. No help forthcoming.
- Paul Barth received letter from Kim Fisher responding to his email regarding Draft vs. Final response to DENR on Sept 9. Fisher stated that it was known that the document was a formal submission. There was also another issue in the letter which will be responded to by Paul.
- Army Corps of Engineer
  - Public hearing has not yet been scheduled.
- Still thinking about possible New Hill, Friendship, and Bonsal Christmas Parade. Paul Barth will contact Larry Sears (Friendship) to see if New Hill can join Friendship parade. Paul Barth has a good chance of acquiring use of a fire truck for the parade!
- New Hill Slogan contest. Mimi Kelly is posting candidates to our web site. Cutoff date for submissions is 12/31/2006. Board will narrow down to 5 finalists and then community will vote for a winner!
- Update from Vickie Gardner on creating a New Hill cookbook that can be used as a fundraiser. Vickie is project lead. Suggested mailing recipes to Vickie or NHCA (P.O Box 68). Vickie is still working. Vickie would like to have a finished product by Mother's Day - 2007
- NHCA eNewsletter is still on back burner.
